Job Purpose:

- Maximise the impact, depth and scale of innovation activity and foreign direct investment in the OxLEP area
- Provide strategic leadership to local partners, promoting the innovation and investment potential of the area with stakeholders such as DIT, Innovate UK and investors
- To lead/support the delivery of the Innovation Strategy through supporting the Innovation sub group, its members stakeholders and partners relevant to its themes
- Lead the inward investment team to deliver the Oxfordshire inward investment proposition to new and existing investors ensuring annual targets are met
- Work alongside the ERDF funded Innovation Support for Business (ISfB) programme to support the delivery of its outcomes

Main Duties:

- Support the Innovation sub group in the delivery of the OxLEP Innovation Strategy, leading, supporting and coordinating the activities of stakeholders as appropriate
- Work with the wider innovation community to identify opportunities to develop and support market sectors and supply chains that are consistent with the long-term innovation led growth ambition for the Oxfordshire economy
- Lead and coordinate a wide range of third party organisations to identify, foster, secure and retain investment that supports the exploitation of innovation across the Oxfordshire economy
- To develop, lead and manage strategic investment propositions across 'Team Oxfordshire' with a particular focus on harnessing the collaborative input of our academic excellence to promote our global assets
- Act as the main innovation and inward investment lead for OxLEP and actively promote and support our potential locally and inter/nationally
- Develop a collaborative approach to engaging key developers, business and science parks and commercial property agents in a way that maximises benefit for all
- Build on the existing infrastructure to optimise the 'Team Oxfordshire' approach to account management of strategic companies
- Support the delivery of the Oxfordshire Science and Innovation Audit objectives
